ALF Resident Assessment Training

24-Hour Mandated Training for Assisted Living Facilities

Training Objective

As required by 198.005 RSMo and 19 CSR 30-86.047, residents of Assisted Living Facilities are required to undergo a community based assessment performed by an appropriately trained and qualified individual. This individual must complete a DHSS approved 24-hour training program prior to performing resident assessments. The MALA ALF Assessment Training satisfies this regulatory requirement.

Who Should Attend?

Anyone who wants training on issues relating to the elderly, aging, certain people with mental illness, and community-based assessments can attend this training.

To meet the statutory and regulatory requirements related to community based assessments, only appropriately trained and qualified individuals may perform the assessment. The term “appropriately trained and qualified” is defined by the following characteristics/credentials:

- Licensed or registered with the State of Missouri in a health care related field, **OR**
- Hold a degree in a health care, social services, or human services field, **OR**
- Licensed under Chapter 344, RSMo (Licensed Nursing Home Administrator), **AND**
- Received facility orientation training under 19 CSR 30-86.047(62), and dementia training under section 192.2000, RSMo.
