## Insulin Administration (IA) Instructor Checklist

- Check the EDL list by phone 573-522-6510 or online at [www.dhss.mo.gov/EDL/](http://www.dhss.mo.gov/EDL/)
- Check for prior Insulin certification by calling 573-526-5686 or online at <https://dhssweb02.dhss.mo.gov/cnaregistry/CNASearch.aspx>
- A person **MUST** have a DHSS Level One Medication Aide certification prior to receiving an Insulin certification. If a person holds a LIMA certification from the Department of Mental Health, please contact our office for information on obtaining a DHSS LIMA certification.

**Once Training has been completed:** Return the following Insulin documents **within 10 days after testing – ORIGINALS ONLY, copies or faxed documents are NOT accepted.**

***\*\*\*Failure to return materials to the certifying agency will result in the Insulin certificate not being issued and the Department of Health and Senior Services will not have record of a student being Insulin certified and may result in the Instructor being removed from the certified instructor list. \*\*\****

Insulin certificates and wallet cards for each student will be sent to the training agency address unless otherwise noted.

- Insulin Training Cover Sheet – must contain the name/signature of the recommending Administrator or DON; legibly printed name of Instructor, phone number and date.
- Copy of each student's LIMA or CMT certificate **OR** a screen print from the Health and Senior Services online registry search at <https://webapp01.dhss.mo.gov/cnaregistry/CNASearch.aspx>. If you do not have access to view the online registry, the Department of Health and Senior Services, Health Education Unit at by calling 573-526-5686 to find out which certifying agency issued the certificate and obtain a copy.
- Original Appendix A – Final Record/Competencies for each student – must contain the name/signature of the recommending Administrator or DON.
- Fee - Company Check/money order - personal checks are not accepted

**MALA's Return Policy:** The Insulin Certification will not be processed unless the entire packet is complete.  
Documents will be returned for the following reasons:

- Failure to submit the original Insulin Administration Training Cover Sheet (all information and signatures)
- Failure to submit Appendix A - Final Record Competencies For Giving Insulin (all information and applicable information and signatures)
- Failure to submit verification of a student's L1MA or CMT
- Failure to submit payment or the incorrect payment

**Insulin Certifications:** DO NOT send the Insulin documentation until after you have received the LIMA certification. Insulin documentation will be returned if it is sent with the LIMA materials. Insulin certification materials **must** include a copy of the LIMA certificate or verification from online search.
